

Solar Plus Storage Incentives for Connecticut, Rhode Island and Massachusetts

Through the ConnectedSolutions Demand Response Program, Eversource customers in Connecticut, National Grid customers in Rhode Island, and both Eversource and National grid customers in Massachusetts can get paid for releasing battery power into the grid.

The incentive is based on the performance of a battery system during a Demand Response Event. The "Demand Response Event" refers to the occasion in which the battery is eligible to release its power to the grid. These events are organized by the utility throughout the year, but never when there is a risk of a grid outage. The event is valuable to the utility as it provides needed power to the grid during peak-demand times. The battery will otherwise be available for the use of the homeowner.

Energy storage providers like Generac, have built-in technology to manage these events for the homeowner. Green Power Energy, in coordination with our battery partners, will submit your ConnectedSolutions application on your behalf, so all you have to do is sit back and collect your incentive.

Batteries are also eligible for the solar tax credit (ITC)!

Please note these are the approved battery storage systems that currently qualify:

- Generac PWRCell
- Tesla
- SolarEdge (National Grid only)
- Sonnen

Program Details:

Eversource "ConnectedSolutions" Battery Rebate (CT):

- Solar battery customers can discharge their battery power to the grid and get paid by Eversource based on the kW the battery can discharge.
- The program is currently available in Connecticut through the end of 2021.
- Eversource has indicated the program will be converted to a five-year program; similar to National Grid in Rhode Island.
- The incentive is worth \$225/kW in the summer and \$50/kW in the winter.
- Based on a 6.7 kW battery system, the average annual incentive payout can reach \$1,842 per year!
- Must have Eversource as a utility provider to take advantage of this incentive.

Program Details:

National Grid "ConnectedSolutions" Battery Rebate (RI):

- Just as in CT, solar battery customers can discharge their battery power to the grid and get paid by National Grid based on the kW the battery can discharge.
- The program is currently available as a 5-year term in Rhode Island.
- The incentive is worth \$400/kW in the summer (there is no incentive in the winter).
- Based on a 6.7 kW battery system, the average annual payout can reach \$2,680/year!

Program Details:

Eversource and National Grid "ConnectedSolutions - Mass Save" Battery Rebate (MA):

- Just as in CT and RI, solar battery customers can discharge their battery power to the grid and get paid by Eversource or National Grid based on the kW the battery can discharge.
- The program is guaranteed through 2023 for those who install or have installed battery storage before May 2021.
- Mass Save sponsor will pay \$225 per kilowatt (kW) for your battery's average contribution during summer events and \$50 per kW for your battery's average contribution during winter events.
- Mass Save sponsor will call upon your battery no more than 60 times per summer and 5 times per winter, with each event lasting a maximum of 3 hours.
- For a typical battery capable of a 5 kW continuous contribution during these events, the ConnectedSolutions program would pay \$1,375 per year of participation.
